

## Hillman & Bond Copy Letter Book 1924 (October – November)

4<sup>th</sup> October 1924: Deeds for 48 Silver Street sent to H C Parham, 64 Broad Street, who purchased it for his daughter.

7<sup>th</sup> Oct: Mrs McMichael received £8 5s 9d as share of quarterly rent for Browns Stores, Bridge Street. Miss A M Clarke of Bristol received the other half of Brown's rent.

9<sup>th</sup> Oct: Deeds & documents of Slopes Farm and Nos. 50, 51, 52 Silver Street sent to G J Knight of Broad Holm(e), Lyme Regis.

10<sup>th</sup> Oct: Letter to Miss M D Cox re her purchase of *Mentone*. Deeds in Midland Bank.

13<sup>th</sup> Oct: Victory Bonds are still accepted for death duties.

14<sup>th</sup> Oct: Tenant of Catherston Farm from March 1924 – Mr C J Wallbridge.

17<sup>th</sup> Oct: Rent sent to M Gale (GD – Mordecai Gale), Monmouth House, from Mr Jewel at Perhams Farm. (GD – Holcombe)

20<sup>th</sup> Oct: Letter to Mrs Sole, 34 Coombe Street asking her to vacate shop premises at 33a Coombe Street by Monday 27<sup>th</sup> October.

Owner: Mrs Warburton.

22<sup>nd</sup> Oct: Mrs Norris, daughter & executrix of Mrs Adams, Uplyme is to sell her mother's cottage, *Woodbine Cottage*, to Mrs Copp.

25<sup>th</sup> Oct: Miss Philpott selling site of Police Station.

31<sup>st</sup> Oct: 63 Silver Street valued at £800 in insurance policy.

3<sup>rd</sup> Nov: Mr W Cork, 22 Sherborne Lane, given notice to quit on sale of property by Mr M Gale to Dorset County Council.

3<sup>rd</sup> Nov: Mr H A Jewson, Mineral Water Works, Yawl in receipt of ½ years rent for Perhams Farm. (GD – Harcombe)

3<sup>rd</sup> Nov: Mrs Pinkney, purchaser of Gibraltar Lodge.

4<sup>th</sup> Nov: Completion of sale of site of new Police Station to Dorset District Council to Mr M Gale, Monmouth Street, for £900.

14<sup>th</sup> Nov: Mr Spiller is tenant of Slopes farm.

15<sup>th</sup> Nov: Proviso on sale of Madeira Cottage for £800 to Miss Fraser that should she sell within two years, the executors of W Barrett should be given the option to repurchase at £865.

28<sup>th</sup> Nov: Freemasons master & secretary, John Henry Sharley & Frederick Paul replacing Walter Spreadborough & Hubert Richard Morgan.
