

### Clarence House, 21 Broad Street, Lyme Regis

In architectural terms, No.21 should be considered as part of the group of buildings, Nos.19-23. A visit by the authors to a second floor flat at No.20 Broad Street confirmed thier belief that today's image of this group reflects Georgian buildings, subsequently adapted to the introduction of shops in Broad Street which began to take place in late Regency/early Victorian times. The former houses themselves are Georgian makeovers of earlier buildings.

### Timeline

The timeline refers to known dates that a person(s) occupies a property. Unless stated, no distinction is made between owner and tenant. Occupations may well extend beyond the known timeline.

1885-1911 - William Notting Farnham, jeweller, watchmaker & gunsmith.



William N Farnham standing outside his shop in about 1900. In addition to his core business, He was also described as a stationer and fancy dealer.

William learnt his trade, with his brother, from their father, James Farnham, who ran his jeweller & watchmaker business from No.61 Broad Street.

1915 - Walter R Wood, jeweller.

1917-46 - Reginald Walter Baker & his wife, Margaret Sarah Baker.

They were astute business people who, at one time, owned much property in the town. Margaret was the driving force & brains behind the business ventures, whilst Reginald's interests lay in Town & County politics. Apart from being Mayor of Lyme Regis, 1928-31, he was also a county councillor and a Justice of the Peace.

In 1917 No.21 Broad Street was the Cosy Cafe & Dairy providing high class confectionery, teas & luncheons, with the Clarence House apartments having 2 sitting rooms & 8/9 rooms. The business expanded involving adjoining properties.

In 1923, an advert quotes, 'The Cosy Cafe caters for Charabanc parties. Accommodation for 400'. The upper floors of No.22 Broad Street were taken over & No.19 Broad Street was also part of this complex of shop, cafes, restaurant & residential hotel. By 1933, they had vacated No 19 Broad Street and taken over the upper floors of No.23 Broad Street.

In 1927, they also owned the Rock Point Hotel, and in 1934, The Gables.

They also bought The Regis cake shop & accompanying bake house, which was later sold to the Co-op. They eventually sold the business at No.21 Broad Street to Mr Hammett after the war, and bought the Bay Hotel and Sundial House on Marine Parade.



1947-70 - Mr R E Hammett took over the business from the Bakers, and for a short time continued with the Cosy Café, renamed the Regis Restaurant, occupying the first floors of Nos.21-23. The business soon returned to only occupying No.21, trading as pastrycook, confectioner & grocer, and continuing to run the Clarence Hotel, which was described as a rabbit warren by a guest staying there at the time.

Hammetts became a V&G grocer towards the end.
