PREFACE.

Roberts in his History of Lyme Regis (1834) at p. 348 says, in writing of the Records of the Borough, "There is a book containing accounts of law-suits, etc., called "Domesday Book". No such book can be found, but the present volume had written on the outside of its paper cover "extracts from Domesday Book." In any event there is not a single reference to any law-suit in the whole of the small volume. It is written mainly in Latin but at times lapses into English. It is all apparently in the same handwriting and cannot have been copied earlier than 1667. It was, in fact, probably copied out much later. If Roberts ever read this or the complete book, he omitted to take note of the names of many early Mayors. His own list begins at 1437, but this book contains at least a dozen names that might have been included before 1547, when his unbroken series starts.

The book itself appears to be a compilation taken from Manorial Court Rolls, Hustings Court Books and the Domesday book of Roberts.

The transcription has been done by Mr. D. B. Wardle of the public Record Office. Full indexes will be found from pp. 19 to 25.

A number in red ink in the typed text refers to the corresponding number in Glossary and Notes pp. 23-25.

23 Glossary and Notes

- [1] Assise of ale (p.5) was held for settling its price in relation to the current price of barley.
- [2] Backside (p. 18) = back premises.
- [3] Bailiffs (p.5, etc.) were apparently the executive officials of the Corporation before the appointment of serjeants-at-mace.
- [4] Burgage (p.3, etc.) was a tenure of land or house held of the king or other over-lord for an annual rent.
- [5] Burgh, John (p.10,12) was not only mayor on more than one occasion but sat for Lyme in the House of Commons in 1478 and 1491.
- [6] Chaplain (p.2) = Chantry priest
- [7] Chernemouth. (1) = Charmouth
- [8] Combe, La (p.2) = the comb, combe, or chine alongside which the river ran towards the end of its course. Its development into Coombe Street was inevitable.
- [9] Copp's Lake (p.14) is often mentioned in Lyme's early records, and it must be premised that 'lake' in Dorset means stream. There is no 'lake' in the , English sense either at Morecombelake or at Venlake (Uplyme). A conjecture might place Copp's Lane at the head of Church Street, where a stream from old Charmouth Lane crossed the footway and, flowing down Church Street, supplied the East of the town with water.
- [10] Croft (p.1) = a piece of enclosed ground attached to a house.
- [11] Curtilage (pp. 1, 3, 4) a small enclosed courtyard attached to a house.
- [12] Danyell, Stephen (p.7) The same incident was more briefly referred to on p. 58 of the Court Records 1437-1508.
- [13] Deanfront (p.8) This may be an error for Beaufront, (1499) often referred to. It may be identical with Bell Cliff. See note on p. 52 of Court Book 1604-08.
- [13a] Donne, William de (p.1) may be he of that name (also given as Doule) who sat for Lyme in the House of Commons in 1341 (Ap. 23rd to May 18th)
- [14] Ellesdon, William (p.17) This William Ellesdon was Mayor of Lyme on 5 occasions and represented the Borough in the House of Commons in 1571 and 1572.
- [15] Galnar, La (p.1) cannot be identified.
- [16] Goldsmith, John (p.1] was not only Mayor in 1338 but represented Lyme in the House of Commons which sat Feb. 3rd-14th of that year.

[17] Helyersbrygge (p.6) cannot be identified. The repair of the same bridge is referred to in the previous year (1478) at p.32 of "19 Court Records 1437-1508".

- [18] High Street (pp.14.15) There seems reason to believe that Broad Street, before being named West Street from about 1550, was occasionally known as High Street
- [19] Hocktide (pp.6, etc.) was the second Monday and Tuesday after Easter.
- [20] 'in fee' (p.1 etc) This expression has reference to property held for the benefit of another by payment of rent or performance of certain services.
- [21] Jones, Robert (p. 18) This is the man of whom Roberts writes(no doubt correctly) as the great persecutor of the Dissenters, In his account of him (p.143 of his book of 1835) he seems to think it worth while to repeat some absurdly fantastic legends. They are taken textually from Hutchin's History of Dorset and must be regarded as the product of a very credulous age. The passage in the text is interesting because, it refers to what was known as the 'Great House' of Lyme. The Tower was the bell-tower of the Leper Hospital of the 14th century. The house from the Pitt House Hotel downwards was probably not very large, but seems to have taken in all the ground along the river at the back from the lepers Well to a broken arch that is in a line almost with the bottom of Broad Street

[Roberts suggests Tower House was below Great House (Aveline House) R.J. already had the Great House by inheritance]

- [22] King's Mill Stream (p.14) This is the depleted part of the river from Goslings Bridge down to what were the Town Mills.
- [23] Lynch, Michael (p.l) sat for Lyme in the House of Commons in the parliament of 1341 (Ap. 23rd-May 14th) Roberts is of opinion that it was he who gave his name to the walk alongside the King's stream closeto which runs the sluice for working the Town Mills, and causes this small body of water in the King stream. See note on "Erslynche" at p.68 of the Court Book 1309-28.

[No, G.R. recanted, Lynch for the hillside above.]

- [24] Mercer, Adam le (p.2) sat for Lyme in the House of Commons in the Parliament of 1344 (June 7th 20th)
- [25] Meryettesbrygge (p.6) This bridge cannot be identified.
- [26] Messuage (pp.17, etc.) is a dwelling with some land attached.
- [26a] Milton Facomberg (p.6) is Milton, a hamlet of Martock Parish, Somerset. It is also called Milton Falconbridge.
- [26b] Nassh (p.16) This is the most eastern promontory of Lyme, extending beyond the church cliffs in the direction of Portland. In the portfolio II of Fugitive Pieces (13,1) it is called "the nase". That was in 1540-42 but since the middle 16th century the extent of it has no doubt been considerably reduced.
- [27] Neweham (p.2) refers to Newenham Abbey of which there are fragmentary remains, part of a farm, just south of Axminster Station. The Abbey which grew to great importance was an offshoot from Beaulieu in Hampshire, in 1246. The meaning of the name spelt in many different ways is simply New Home. The Abbey was dissolved in 1539.

- [27a] Penyme(a) de (14), according to the Colway Tithing Boundary Award at Folio 11 of Portfolio IV, seems to have been a plot to the East of the Church between old Charmouth Lane and the sea.
- [28] Peritree Croft (p. 15) cannot be identified.
- [29] Pyne, John (p. 13). A man of this name sat for Lyme in the House of Commons in the Parliament of 1529/36, but against him on the list of Lyme M.P.'s is the word "mortuus". It cannot be said whether he ever took his seat or not, and Lyme's Register of Burials does not begin till 1579.
- [30] Pypowder Court (p. 5) This statement of 1472/3 gives the lie to the suggestion that the Court was first granted by Queen Mary in 1553. Queen Mary's charter was the first to mention it, but a Piepowder Court to settle differences over market dealings on the spot had no doubt existed in Lyme from time immemorial.
- [31] Reeve (p.9) here probably means steward or bailiff; but higher officials were "reeves".
- [32] Roze, Richard (p. 17) For a full account of this important burgess see note at p.108 of the Register of Freemen.

- [37] "Temeceaur" (p.13) no solution of this word is possible.
- [38] toker(p.13) = tucker, fuller
- [39] Tower, the (p.18) See 'Jones, Robert' above. The tower house is Aveline, now owned by Lloyds Bank
- [40] Wadham, William (p.10) of Catherston, Charmouth, was evidently steward of the Court Leet on this occasion and he is so named on pp.62 and 67 of "19 Court Records 1437-1508". He may also have been Recorder of the Borough as were Sir John Wadham who died in 1584 and George, son of Sir John, who is described in Elizabeth's Charter as Lyme's "First Recorder". But William is never actually spoken of as Recorder.
- [41] Wathe (p.7) means a fordable place and there are many such in Lyme Though the word occurs often, identification is impossible. See note on the subject in Portfolio 11 of Fugutive Pieces at folio 102, p. 16. [Ware .v. Henley estate papers]
- [42] West Street = Broad Street. See note on "High Street" above.
