

Hillman & Bond Copy Letter Book, April 1931 - January 1932

Summarised by Judith Clarke, LRM Research Team (June 2011)

April 18 1931

To Mrs. Wiscombe, 36 Broad Street, Lyme Regis.

Reference Cawley.

Hillman advised Mrs. Wiscombe may need to attend County Court unless defendant pays prior to the hearing.

April 22 1931

To Mrs. N. Wiscombe – Cawley had paid in amount due, with costs, and Hillman will obtain money from Axminster County Court.

April 20 1931

To Mrs. Bruce, Coombe Street, Lyme Regis – may need to attend Axminster County Court unless Mr. Savage pays before hearing.

April 21 1931

To R.J. Boalch, 15 Marine Parade, Lyme Regis

To Stanley Evans and Company, Solicitors, WC1.

Hillman wrote that Mr. Boalch was surprised at objection to installation of window affected their client's property. A larger window in same wall overlooked their client's property and is admitted to be an 'ancient light'. Mr Boalch admits not being entitled to open the new window and Hillman suggested Stanley Evans accept this and requested form of letter for signature, and their client bear any costs she may have incurred.

April 29 1931

To Stanley Evans and Company, London

Mr. Boalch is not averse to entering into an agreement as suggested by Stanley Evans and Company, provided Mr. Boalch is protected against capricious actions by Miss Steventon in terminating it. Mr. Boalch surprised Miss Steventon he pays her costs as he does not believe that the opening of this window can possibly interfere with any practicable development of their client's property. Mr. Boalch refers to a chimney at her property built against his house as to be an encroachment, which he has never raised before and would not have done so but for their client's attitude. Hillman suggests their client reconsiders the costs as otherwise Mr. Boalch will consider asking Miss Steventon to move the chimney.

May 11 1931

To Stanley Evans and Company.

Mr. Boalch not prepared to sign the suggested agreement regarding the window, unless their client signs similar agreement regarding the chimney. Hillman says chimney is more detrimental to Miss Steventon's property.

April 22 1931

To Miss Marder, 29 Broad Street.

Requested licence previously sent for signature. Hillman advised her sister had asked them to collect arrears of rent of £37.10.00

April 24 1931

Reference Mrs. Amelia Cook deceased

To Mayo and Sons, Solicitors, Seaton. Hillman had been consulted by Mrs. Hilda Wallbrother, Lyme Regis, on behalf of herself, brother and sister.

Mayo acted for Mr. William Badcock of Seaton, administrator of the estate. The deceased died intestate in February last, a widow with no children. Mrs. Wallbrother? believes she and her siblings, as the representatives of her father Joseph William Badcock, should share in the estate with their uncle, the

administrator. Estate consists of £1200 to £2000. Hillman asks to know when administration complete and distribution expected.

April 28 1931

To Mayo and Sons. Hillman's client, Mrs Wallbrother, states her father was a brother of the whole blood to Mr. W.L. Badcock. Joseph Albert Ingerson Badcock from Cardiff, Mrs. Evelyn Mary Blackall of London and Mrs. Hilda Constance Walbrother of St Andrews Cottage, Haye Lane, Lyme Regis. Hillman requested details of estate and its distribution.

May 1 1931

To Mayo and Company. Consulted Mrs. Wallbrother and her mother (widow of J.W. Badcock. Both were under impression Mrs. Birch was half-sister of deceased, being youngest child of late John Badcock by his first wife, whereas deceased, administrator and J.W. Badcock were children of his second marriage. Dates of birth of children of John Badcock and his daughter Sarah Jane Badcock (later Burch) born 18 May 1853. Birth certificates required to show who her mother was and to prove whether own or half-sister of deceased.

May 6 1931

To Mayo and Company. Hillman's client satisfied to accept late Mrs Burch was own sister to her father and uncle. Mayo to proceed on these lines.

April 27 1931

Reference Henley Estate and The White Rose Laundry, Lyme Regis.

To Pitfield Chapple and Measures, Solicitors, Axminster.

Pitfield had completed the purchase. Hillman undertakes to obtain, if necessary by Mr. H.Cawley/Hawley?, on behalf of Mrs. J.K. Pinkney and her personal representatives, a Deed of Confirmation or Release to be executed by Mr. T.G. Matthews or his personal representatives. This relates to outstanding legal estate (if any) vested in him by two Transfers of Mortgage, both dated May 2 1910. The estate may not have been completed by an Indenture of Reconveyance of May 20 1919.

April 30 1931

To Lloyds Bank, Andover, Hampshire.

Hillman glad to hear sale by Mrs. Pinkney of Laundry completed.

April 22 1931

To Miss Marder. Stated Mrs. Beer had seen Hillman to say the house was in a bad state of repair, etc., and would like to take it over from Mrs. Case, and would Miss Marder consider selling to Mrs. Beer.

Hillman requested licence to assign from Miss Marder.

April 29 1931

To Mrs. Beer, 28 Broad Street, Lyme Regis

Miss Marder does not wish to sell. Assignment to Mr. Beer enclosed. Licence to assign to be sent later with note of charges. All future rent to be paid to Mrs. Beer's husband, direct to Hillman.

Reference Raymond House, Lyme Regis

To Solicitors, Axminster.

Miss M.H. Marder refutes that the state of the rooms are in poor condition. They are quite sanitary and habitable. In view of the small rent being paid, she and her sister are not prepared to do extensive repairs. If wet is getting through, will arrange to have slates repaired and replaced. The Misses Marder are prepared to accept surrender if necessary.

April 28 1931

Reference Merle Bank, Lyme Regis

To Petersons Snow and Company, London.

Hillman's client arranging with rate collector to pay rates up to date she gives possession. Hillman undertaking to discharge anything up to completion. Apportion fire insurance from 27 February to 24 June, say half of one guinea (annual premium) to be added to balance of purchase money.

April 30 1931

To Miss Gough to finalise arrangements of sale of her property to Mrs. Snow.

May 11 1931

To Petersons. Arranging completion for 15 May 1931.

April 28 1931

Reference Miss C. M. Bigg deceased

To Miss Collins, Frankesholme?, Lyme Regis

Hillman acknowledges papers from Miss Collins and cheque being sent to Death Duty administrator. Various forms being sent to Mr. Bigg and matter nearly completed.

April 28 1931

Reference Emmett

To Mr. Hilditch of Sun Insurance Company, Bournemouth.

Mr. Emmett wishes to take out accident cover policy for himself and his three partners as they are only working men and could not afford to be away from work unless in receipt of some form of compensation. They are erecting houses under Housing (Financial Provisions) Act 1924.

May 6 1931

To Mr. E.R. Emmett, 37 Colway Mead, Lyme Regis.

Three forms enclosed regarding Mr. Emmett's partners being abstainers from alcoholic liquor. Forms to be signed and returned. No reduction for total abstinence under fuller proposal regarding Mr. Emmett.

May 5 1931

Hillman suggest approach to Mr. Emmett's doctor if more information is needed regarding accident.

Although severely damaged leg at time, Hillman states Mr. Emmett does not walk at all stiffly. Three declarations regarding alcoholic liquor enclosed.

May 19 1931

To Mr. F.W. Newbery, 8 Coombe Street, Lyme Regis.

Completion from Mrs. Newbery to son of Mr. F.W. Newbery of 8 Coombe Street, Lyme Regis and stores adjoining.

May 19 1931

Letter to Mrs. Newbery. Filling Station, Shute Cross, near Axminster, Devon.

Completion of 8 Coombe Street. Deeds to stay with solicitors or posted if required.

May 19 1931

Reference Whalley Cottage

To Mr. E.A. Washer, Hill Road, Lyme Regis.

Miss Wyatt had executed conveyance.

Reference Cottage near Talbot Arms, Uplyme

Solicitors advised that vendor is a Mrs. Elstob and there is no objection to early completion.

May 20 1931

Mrs. Elstob had recently sold cottage to Mr. Washer and they had prepared conveyance and enclosed for her signature, for return and completion.

Mr. Washer had paid balance of purchase money of £157. 10. 00. Cheque enclosed for £155. 04. 03.

Deeds ready to collect. Balance of purchase money of £238. 10. 00, charges £3. 03. 00, stamp £1. 07. 06, search fees 6 shillings and 6 pence, total of £4. 17. 00.

Letter received from Mrs. Carlyle's solicitors, also sketch plan referred to. Purchaser anxious to complete next Monday. Hillman understand from Radford that gutter altered a while ago to meet Mrs. Elstob or her tenants' objections. Can Mr. Washer say anything as to the 'vaults' – does the Talbot Arms use them or claim any rights to them.

July 28 1931

Today completed sale of cottage to Mrs. Carlyle. Cheque enclosed for £325. 14. 00 and receipted account for £4. 05. 01.

May 19 1931

Conveyance received from Roderick and Richards and Mrs. Marker to execute tomorrow. Balance of purchase money appears to be £607. 10. 00 and £2 due from Kitson and Trotman's client.

June 10 1931

To Mr. Joseph Curtis, Church Cliffs, Lyme Regis

The present owners, the Parochial Church Council, giving notice to quit and deliver up possession of part of land. Tenancy ends January 1 1931 and council probably prepared to enter into agreement on different terms before tenancy ends.

June 12 1931

Reference Miss Steventon and Mr. Boalch

To Stanley Evans and Company

Suggest mutual agreement, i.e. they each pay a similar sum of, say, one shilling for the chimney.

Carrying the chimney pot above the eaves will not entail a very heavy expense to their client. Advised agreement.

Hillman had heard from Mr. Paul that Mrs. H. Pringle agreed to buy for £1380.

Today completed sale of above property. Cheque enclosed for £1231. 10. 00, balance of purchase money less costs.

Now completed purchase. Title deeds, abstract and certificate of search enclosed and note of charges.

December 31 1931

Acting for Mr. F. J. Creswell reference purchase of part of land adjoining Summerhill, Charmouth Road. Price is £260 and frontage is 90feet. Before proceeding Mr. Creswell needs to know position of drain or sewer under part of land, which he understands carries draining of Cumberland Cottage to join public sewer near bottom portion of same field. Has owner definite casement for drain and propose to sell subject to such? Believe drain laid on behalf of Colonel Healey, one time owner of Cumberland Cottage and the field, and passes under whole of field in question, certainly through plots recently agreed to be sold to Hillman's client Mr. Halliday.

Mr. Harvey had signed his charge so sending conveyance to Mr. Lane for signature so it can be stamped and completed on return. Harvey mentioned Emmett had not started on repairs and asked Mr. Lane for help to get him to do so.

Hillmans acting on Mr. Lane's instructions prepared supplemental charge for further sum of £50 reference 15 Coombe Street. Mr. Harvey to call and sign charge.

Principal and interest due on above mortgage on property is £8. 12. 06, total quarter's costs.

September 16 1931

Hillman's client, Mr. F.G. Isbell of The Bazaar, Lyme Regis, asking for payment of £2. 05. 00 for three dozen calendars supplied to his wife. As his wife had not replied or paid, Mr. Sirell? was being approached to pay by Saturday September 19 1931.

October 3 1931

To Mr. F.G. Isbell, 8 Broad Street, Lyme Regis.

Summons issued against Mr. Sirell?, defendant, to pay into court or Mr. Isbell to attend county court date for hearing. To prove goods were ordered and supplied, plaint note enclosed.

September 18 1931

Reference Culver, Uplyme – Smelling to Quick

Mr. Quick today completed purchase of above property. Cheque enclosed for £490. 16. 00 purchase money, less charges of £4. 04. 00. Receipt send direct to Mr. Smelling.

September 28 1931

Mr. A Wiscombe of A. and F. Wiscombe of Lyme Regis instructed Hillmans to act.

October 3 1931

Contract agreed on behalf of their client, Miss Hewitt, by Andrews Son and Huxtable, who asked as to ownership of steps leading to footpath and whether their client would be responsible for repair of same. Also agreeable Mr. Wiscombe should have garden produce as it matures but not later than mid-February.

Rental account enclosed for September quarter and cheque for £18. 02. 03 to balance.

Instructed by Mr. W.R. Wallis, owner of the yard used in common by Mr. Hodder and various neighbourhoods – not to cause obstruction of the entrance by cars or carts, with entrance to large shed or the two ways leading to the cottages and land on higher level.

Mrs. Homyer and brother required to sign affidavits reference mother's probate.

Miss MacKinley consulted Hillmans reference dismissal of manageress at laundry, without notice. Client entitled to at least week's pay in lieu of notice and asked for cheque for week's money.

Mr. Cawley's solicitors telephone Hillmans. Alleged Miss MacKinley forfeited claim to notice by being insolent to Mr. Cawley and paid for four days work. Miss MacKinley to telephone Hillmans.

October 23 1931

Telephone call from Mr. Cawley's solicitors offering sum of £3. 05. 00 in settlement. Miss MacKinley may not accept.

October 22 1931

Deeds sent of Cobb Buildings and yard, including earlier conveyance and fire policy.

November 5 1931

To Mr. W.H. Pidgeon, 17 Millgreen, Lyme Regis

Conveyance of Bakehouse to Mr Gage sent for Mr. Pidgeon's signature.

November 6 1931

To Mr. J.A. Gage, 9 Sherbourne Lane, Lyme Regis

Conveyance executed by Mrs. Homyer and Mr. W. Pidgeon of the Bakehouse. Getting conveyance stamped and then send deeds of property to Mr. Gage.

November 5 1931
