Court Book Calendar 1604 - 1608 PREFACE.

This is the first Lyme Court Book of the Stuart period, and the Calendar of it runs from February 1603/4 to April 1608.

The work of transcription has been done by Mr. J. R. Crompton of the Public Record Office, London. There is a small but unimportant gap between this and the previous Court Book.

The usual Indexes and Glossary will be found at the end of the volume.

The numbers of the pages given in these Indexes refer to those at the bottom of each typed page.

Numbers in the margin of the typed pages refer to the folios of the original Court Book.

Numbers in red ink in the text refer to the corresponding numbers of each item in the Glossary (pp. 52-62). [these are not copied R-W.]

the wall for avoiding of danger to children, and therefore doth incur the pain of 20s.

And that the widow Sicke's mantle is not amended according to the order and therefore incurred the pain of 3s.4d.

And that Mr, Benjamin Gosse hath not set up the bond stone in the garden by John Cogan's house as he was enjoined the last Court, and therefore hath incurred the pain of 20s.

And do also present upon the constables' bill that the 2nd day of this April Martyn Dolman and Richard Butcher played at tables in Robert Barnes' house, and therefore in mercy.

And that John Powning, John Ollyver, Nathan Batten, John Bonner, and Richard Shuer played to cards in Henry Bruer's house the 3rd of this April, and therefore in mercy.

And that Benjamin Hill and Richard Hobbes the same day played at cards in William Moxedge's house, and therefore in mercy.

And that Edward Bankes and John Samford played at bowls the eleventh of this April, And therefore in mercy.

GLOSSARY AND NOTES.

Affeerors (pp. 17, 21, 22, 27, 30, 32, 34) settled fines and mulcted those who had incurred penalties.

Amercements (pp. 1, 16, 20, 82, 30) = fines

Apprisers (p. 1) are what we should call appraisers, i.e., valuers.

Assize of the King (pp. 37, 40) refers particularly to that held for fixing the statutory price of bread and ale, according to the price of grain.

Auditors (pp. 1, 2) hardly correspond to the modern professional accountants who settle the assets and liabilities and draw up a profit and loss account for a commercial undertaking. They were probably more in the nature of referees who had to adjudicate on small differences in the figures of two disputants.

Beaufront (pp. 24, 39) It is impossible to say for certain whether this place was identical with Bell Cliff or not. p.39 shows that there were steps, with a railing and a wall and a house there. This might suit either Bell Cliff or Gun Cliff. But according to Fugitive Pieces II, fo. 82, p.1,3 unlawful games, such as dicing (1609) were played there. This seems to suit Bell Cliff better than Gun Cliff. Roberts' remark on Beaufront (p.344 of his Social History) is so vague as to be quite useless. See note on Beaufront at p.2 of Glossary and Notes on Fugitive Pieces II. When was Bell Cliff first so called?

Bell, The (p.39) There is no Bell Public House in Lyme at present (1935) but a Bell was among those applying for a new licence in 1708. Its situation is not known.

Board of hall (p. 21) means that the money was paid out on to the Council Table to be transferred to the account of the town and locked up.

Bondstone (p.40) = boundary stone.

Books, washing of (p.39). Exactly the same, and apparently inexplicable, expression occurs in Fugitive Pieces II, fo. 79, p.l. The meaning is that people were not to wash their dirty linen in the water-course running down the street for the use of everyone. Buck-basket, meaning a basket for dirty clothes, occurs in the "Merry Wives of Windsor", see note on the passage quoted above from Fugitive Pieces II.

Bowls, playing of (p.22) This innocent game was objected to, not so much for say gambling that might have been connected with it, as because addiction to it interfered with the practice of archery, a matter of prime importance in previous centuries, but becoming less urgent at the date of this book.

Bristol (p.33) This reference to Bristol is very interesting. It bears on the considerable trade done between Bristol and Lyme in past centuries by means of pack-horses. To avoid pirates and the dangerous Cornish coast, it was found safer and quicker to send cargoes overland to Lyme. We may presume, too, that cargoes

were landed at Lyme and sent on in this way to Bristol. If both places dealt In cloth and "Welsh frieses" came into Lyme via Bristol, it is difficult to see what profit there was in this commerce.

Burgage (pp. 25, 26, 34, 35) is an urban tenure held of the King or other landlord at an annual rent.

Capital Burgess (pp. 17, 24) was the title given by Elizabeth's Charter of 1591 to members of the Borough Council.

Certiorari, writ of (p.9) was directed from a higher to a lower court with an order for a certified copy of proceedings.

Cobb Receivers (p. 19) had to collect and account for all Cobb Dues. "For not bringing in his books and perfecting his accounts as Cobb Receiver," Marcus Barnes lost his freedom in 1607 (p.36)

Cobham, Lord (p.16) Henry Brooke, Lord Cobham, was at the time Lord of the Manor of Colway. There must have been a touch of humour in naming him as a defaulter for non-appearance before Lyme's Court Leet in April 1604, for he had been tried in 1603 for his association with Raleigh and others for the plot to "kill the king and his cubs" and place Arabella Stuart on the throne, and was now in the Tower.

There he remained till 1619 when he died, "probably of hunger" says the Complete Peerage. With him the title

expired and the Manor of Colway passed before long to the Henley family.

Commoner (pp. 20, 27, 32, 34, 37) in this book probably means a member of the community, a burgess, and nothing more.

Corpus cum causa (pp. 9-11) See note on "habeas corpus". Corpus cum causa is one of the forms of writ of Habeas Corpus which is no longer in use and deserves a separate note. It was employed when in an action in an inferior court, a defendant had been arrested. This having occurred, the next step is to remove the proceedings to the court above and bring up the body of the defendant. At the same time a statement of the date and the cause of the arrest has to be laid before the court.

Decyners (pp. 16, 20, 22, 27, 32, 34, 37, 39) all desiners members of a "decena" or tithing. Devon / Dorset - dozens (p. 33) were kersies of coarse woollen cloth made in either of these counties.

Dunsters (p.33) were a woollen cloth derived from the town of this name in Somerset.

Error, writ of (pp. 9-11) is brought in to remedy a mistake in pleading.

Essoins, essoined (pp. 20, 21, 27, 30, 32, 38, 39) refer to valid excuses accepted as adequate reasons for non-appearance before the Court.

[ad] Execucionem judicii (pp. 10, 11) is a writ nominally from a higher to a lower court to proceed to carry out a decision already given.

Fines, disposal of (pp. 36, 34) The allocation of that on p. 34 to the purchase of cushions for the Town Hall and of the other for the relief of four fatherless children will be noticed.

Fitzjames, John (pp. 15, 23) of Leweston succeeded George Wadham as Recorder of Lyme Regis in 1599, (see Court Book 1592-1602, p.26, and note at p.71)

Foreign goods / foreigners (pp. 14, 21, 23, 27, 31) When it is remembered that a 'foreigner' was one not free of the Corporation, and that 'foreign goods' were goods owned by such men, these passages become intelligible.

Frankpledge (pp. 15, 19, 25, 29, 32, 37, 38). The court of the View of Frankpledge was always the official title of the Court Leet held twice a year. The "pledge" given is that by every burgess of decent and neighbourly civic conduct.

Freke, John (pp. 7, 8) was one of the attorneys accredited to the Mayor's Court at Lyme. See Court Book 1592-1602 pp. 15 and 20 and notes on p.67 ("Attorneys") and on p. 71 ("Freke")

Geare, John (pp.8, 14) Vicar of Lyme Regis from 1608, matriculated at Magdalan Hall, Oxford, in 1583, when he was 16, but took his M.A. from Queen's College in 1594. He had been a schoolmaster at Wimborne and Sherborne before coming to Lyme. His views in 1606, the earliest mention of him in this book, were too Puritanic even for Lyme Regis at that date. But in the next 35 years, Lyme was becoming more and more sectarian, more and more anti-Episcopal. However, even in those early days of opposition to the Church of England,

Geare created much dissension in the Borough Council by drawing over to his side, Robert Hassard, an ex-Mayor and an ex-M.P. The latter was in consequence actually dismissed from the Council by Resolution in 1603. In 1603, Geare was not yet Vicar, and the Resolution described him as "an unbeneficed preacher who hath hitherto been the cause of great factions and dissensions amongst us." Later on, about 1612, Geare did something still more notable, for he succeeded in abolishing the annual festivity known as the Cobb Ale. This event had always been good for the revenues of the Cobb, but it also led to great "unseemliness" and disorder. Robert Hassard came back on to the Borough Council in the end, but the Cobb Ale was never revived. Geare seems to have retained the vicariate till his death and,

according to Foster's Alumni Oxonienses this occured before December 27th, 1645. The living was then in the gift of the ultra-protestant Ellesdons.

Habeas Corpus (pp. 9, 10, 11) The varieties of this writ mentioned on these pages, between the years 1604 and 1607, emphasise the fact that it existed in name long before the well-known Act of 1679. Under that Act, the right was more easily enforced.

Hassard, Robert (pp. 12, 36) Represented Lyme in the House of Commons in 1588/9, in 1592/3, and possibly in 1621/22 and 1624, for the Robert Hassard, M.P. for the latter years may have been his son. He was

Mayor of Lyme 1600 / 01 and consequently a Freeman, notwithstanding the fact that he lived at Charmouth. He was son of the John Hassard who was Mayor in 1556 and 1557 and cousin of John Hassard "seven times Mayor," who died in 1612. For his religious opinions see note (33) on Geare above.

Hendley, Robert (p. 6) may possibly have been Robert Henley of Leigh House, Winsham, and grandfather of Robert Henley, who came into possession of Colway in 1629, and of Henry Henley who was both of Leigh and Colway. The latter was M.P. for Lyme at times from 1658 to 1695.

Hocktide (p.15) was the second Monday and Tuesday after Easter Day.

Husting (p.15) is literally "house assembly" and the Court was used as a place of local jurisdiction and record.

Illerie, John (p.30) It seems likely that we have in this man's name the origin of the local place-name variously spelt as "Hilleries", "Illeries", and "Ylheryes". It was the plot or close in the angle formed by the junction of the Cobb Road with Sidmouth Hill. It is now (1935) being built over.

Jeffrey, Sir John (pp. 6, 16, 21) of Newlands, Charmouth and Catherston was knighted in 1603, and died in 1611. His gravestone is in the chancel of Whitchurch. His son, George, represented Lyme

in the House of Commons from December 1609 to the end of that Parliament in 1611. Whether he took the place of John Hassard, declared "bedrid" by the House of Commons in February 1609, or of Sir George Somers who died in Bermuda the same year, it is impossible to say. This family had no connection with that of the notorious Judge.

Jurden, Sylvester (pp. 8, 11, 18). This notable and (on one occasion) contumacious burgess of Lyme, went with Sir George Somers to Bermuda (see note 58 on p. 74 of Court Book 1592-1602).

Mantle (p. 39) is the piece of stone or timber supporting the masonry above a fireplace. The constant dread of fires in Lyme, with its thatched roofs, made the condition of these "mantles" an object of incessant care.

Messuage (p.37) is, first a portion of land for a dwelling with its appurtenances; then the dwelling itself with the outbuildings and the adjacent land.

Newfoundland (p.37). This system of payment for work done in the Newfoundland Cod Fisheries by partition of the catch is interesting. The earliest known date of Lyme's association with these fisheries is February 1561 (see Court Book 1560-1564, p.19). At the passage quoted, the place and the harvest are spoken of as "Newland pfysche".

Norrington, Simon (p. 24) was the predecessor of John Geare (see note 33 above) in the vicariate of Lyme.

Oath of allegiance (p.17) "All persons above the age of 12 years are to be required to take the Oath of Allegiance in Courts-Leet" (Jacob's Law Dictionary, 1729).

Pack (p.33) The exact dimensions of a 'pack' are difficult to determine. It would be the load normally placed on a pack-horse.

Parcel (p. 23) part of

Procedendo (pp. 9, 10, 11) is a writ whereby an action is removed from a lower to a higher Court.

Ragman Rowe (pp. 16, 20-22, 27, 30, 32, 34, 37, 39) The scribe, having hit on this as a convenient description of Lyme's Black Book of Defaulters, will not let it drop, see note p. 77 of Court Book1592-1602.

Shomake (p.23) is the sumach tree, the leaves of which were used in dyeing.

Somers, Sir George (pp. 5, 14, 17, 18, 20, 23, 28) Of this distinguished citizen of Lyme, so much is known that little need be said. We have in this book (pp. 17, 18) his election as Mayor for 1604/5, and his appearance (p. 28) as witness in a law-suit.

Tables (p. 46) i.e., boards, for backgammon or other game of chance.

Tapnetts (p.21) of figs, is "tapitts" or "toppets" i.e., rush baskets in which figs were imported. The same word occurs in the same connection at folio 13, p.4 of the Portfolio II of Fugitive Pieces. Roberts (p. 353) transcribes the word as "tapmates".

Tipplers (pp. 27, 32, 38) in these passages are beer sellers rather than beer-drinkers.

Titherlie (p. 32) "Mr. John Titherlie, Esq." Who received the freedom of Lyme in October 1606 was probably a distinguished stranger, such as one of the Titherleys of Chardstock, the tall entrance arch of whose former Manor House can still be seen on the left-hand of the road from Axminster to Chard about 4 miles out of Axminster.

Town Mill (p. 24). This property, at the bottom of the same enclave off Coombe Street as that where the Electric Light Plant (1935) is, was for many centuries a constant source of revenue for Lyme Corporation.

Tucker (p. 35) was the fuller, shrinker, and finisher of cloth. He originated one of the commonest surnames at Lyme and throughout England.

Tudboll, William (p.35) whose name is also written Tudbold and Tudoll was as notable a burgess. Mayor and freeholder of Lyme as his brother John Tudbold of the Almshouses. He died in 1553 and by his will directed that his body should be buried in the parish church at Lyme "as nye unto my brother John Tudbold as convenyent".

Wardsman (p. 12) is here the giver of an award.
