We have been consulted by Miss Chalmers of Lower Ware Cottage, in reference to the nuisance caused to her property by your overhanging trees, which are making some of our client’s rooms practically unusable owing to the damp and to the fact that it is impossible to light fires. We understand that our client has repeatedly asked you to have the tree or trees in question cut down or adequately lopped and that you have consistently refused to take any action. The position has become intolerable and we are instructed to give you notice that unless the tree or trees in question are adequately dealt with within 7 days, our client will have no alternative but to take proceedings to compel you to abate the nuisance. We must therefore ask you kindly to give the matter your immediate attention. Yours faithfully...”

(Can't read all this but something about coming to a satisfactory solution if possible), “but you must not go upon your neighbour's land to do what is necessary without her permission.”

In further reference to our letter of the 24th inst, we have now heard from our client, who states that the damage done by your tree is of a substantial nature, causing serious damage to her rooms. In the circumstances, she is not satisfied that the nuisance can be fully abated by such cutting as she is legally entitled to do and we must once more give you notice to take the necessary steps to abate the nuisance within seven days.”

Mr Whetham informed me that Miss Day was willing that everything within reason should be done to meet your wishes and suggested that he and I should meet on the spot and try to come to some arrangement.

Before I meet Mr Whetham if you would like me to do so, I should prefer to have a look at the place myself, so that I may clearly understand the position of the various trees and shrubs referred. In the circumstances I shall be pleased to call round tomorrow afternoon, about 3.30 if Mrs Jenkins will show me the trees and discuss what we had better propose to Mr Whetham in order that we may reach a satisfactory arrangement.

Unless I hear from you to the contrary, I shall hope to call as suggested above tomorrow. Yours faithfully....

P.S. Since writing the above, I have again heard from Mr Whetham that Mr Cooper's men were at work again which he thought might be detrimental to an amicable settlement, but I have ascertained from Mr Cooper that his men are strictly confining themselves to cutting from your roof, such branches as are overhanging."

"Dear Sir. We are in receipt of your letter of 4th inst. And took the opportunity on Saturday afternoon of calling at our client's house to inspect the site and the trees and shrubs. We found that the work of cutting had been completed and it seemed to us that the men doing the work had been most careful to cut only what was overhanging. We also saw Mr Cooper who was in charge of the work and he felt sure that everyone would be satisfied. It is quite clear that in the spring the new growth will again overlap and we trust your client will see her way to direct her gardener to do any necessary lopping in the future. In regard to the last paragraph of the letter in reference to the windows in the little cottage, if these windows are absolutely new and do not merely replace old ones in the previous building, I think Mr Whetham's contention is correct and that Miss Day would have a right to block them up and that a short agreement on the lines indicated should be entered into. If the windows are new, shall I ask Mr Whetham to let me have a draft agreement, for which I fear, you will be expected to pay the costs. Yours faithfully...."

"In reply to your letter of 7th inst. We are informed that the new cottage is the property of Mrs Jenkins the companion and housekeeper of Miss Chalmers and not of the latter. We have seen Mrs Jenkins who states that there are only two windows which overlook your client's property and she is not prepared to enter into any agreement with the latter as to these or to pay her anything in respect thereof and she states that if she wishes to do so, your client can put up some form of screen or board as it will be little if any worse than the trees and shrubs are at present.

In view of the second paragraph of your letter, we had thought of suggesting that without any detriment to her property your client see her way to cut down some of the high Laurels or other evergreens to a considerable extent which would to some extent meet our client's objections.
